



Privacy Policy

OffshoreCrew AS values your privacy in your personal information and content that is stored in OffshoreCrew AS (the "Service"). This privacy policy summarizes your privacy rights regarding our collection and use of your personal information using our Services.

BY USING THE SERVICES, YOU CONSENT TO THE COLLECTION, USE AND TRANSFER OF YOUR PERSONAL DATA FOR PROCESSING AS DESCRIBED IN THIS PRIVACY POLICY

Information Collection and Use

We collect and use your information below to provide, understand, and improve our Services.

Account and User Information: If you use our Services you must provide us with some personal information, such as your name, username, password/PIN code, email address, phone number, CV, competence etc. We may use your contact information, such as your email address or phone number, to customize your account or enable certain account features, for example, for login assistance. We may use your contact information to send you information about our Services, our Clients and job opportunities.

User Generated Content: Some of our Services, like , requires input information and content like text, files, CV, pictures.

Log Data: When you use the Services, we automatically receive and record certain information from your computer, mobile phone, tablet, or other device. This may include data such as your IP address, the pages you visit or features you use within the Services, the date and time of your activities on the Services, the URLs from the websites you visit before and after navigating to the Services, your software and hardware attributes (including operating system type and version, App version, device type, and device identifiers), your browser type and version, and your general geographic location derived through your IP address (e.g., your city, state, or metropolitan region). To obtain such information, we may use web logs or applications that recognize your device and gather information about its online activity. We collect this information to generate usage statistics to help monitor and improve our Services.



Cookies: Like many websites, we use cookies and similar technologies to collect additional website usage data and to improve our Services. A cookie is a small data file that is transferred to your computer or mobile device. We may use both session cookies and persistent cookies to better understand how you interact with our Services, to monitor aggregate usage by our users and web traffic routing on our Services, and to customize and improve our Services. Although most web browsers automatically accept cookies, some browsers' settings can be modified to decline cookies or alert you when a website is attempting to place a cookie on your computer. However, some Services may not function properly if you disable cookies.

Information Access and Disclosure

You may get right of access to the data OffshoreCrew AS has registered about you by sending a written and signed request.

Information that can be linked to you personally will not be shared with others unless it is stipulated in this agreement or founded on the law, or if you have specifically agreed thereto.

OffshoreCrew AS can share your personal data with clients who OffshoreCrew has a "Data Processor Agreement".

Data Storage and Transfer

OffshoreCrew AS stores information which is provided when you are registered as a user in OffshoreCrew recruitment system and which is generated when you use the service.

Personal data will not be stored longer than necessary to carry out the purpose of the processing. Thereafter, the data will be deleted, unless the information will or can be stored beyond the statutory time period.

Changes to Policy

As the Service evolves, we may need to update this Policy to keep pace with changes in the Service, our business and laws applicable to us and you; we will, however, always maintain our commitment to respect your privacy. We will post any revisions to this Policy, along with their effective date, in an easy to find area of our web site and application, so we recommend that you periodically check back here to stay informed of any changes.
